Capital Nature is a leading investment firm focused on incubating, funding and accelerating early stage ventures in innovative New Energy technologies in Israel. We invest in Smart Grid, Smart Cities, Electric Transportation, Energy Storage, Renewable Energy enablers and Energy Efficiency technologies. We invest in outstanding entrepreneurs with IP-based technologies. 4 portfolio companies already raised follow-on investment rounds, and 3 companies are already in commercial phase. We are leveraging our investments by OCS grants in the last 5 years, and received extension for additional 4 years.

Total shareholders investments – 8.8M\$ (13 portfolio companies); Current valuation – 19M\$ (2.3X); This unique investment opportunity at 16M\$ represents a 15% discount over current valuation.
